I. RIGHT OF WAY MANAGEMENT ORDINANCE 906

CMBR Rhoades followed up on the discussion during the Committee of the Whole regarding the clustering of utility vaults on a single property.

Mayor Marquardt stated that it has been common practice for residents to screen the vaults with either landscaping or fencing that allows for access by the utility companies.


City Attorney Shortlidge directed the Council's attention to Section 13-809(e) of the ordinance which gives the Public Works Director or another designee some discretion in approving locations of the utility vaults

Public Works Director Leon noted that utility companies tend to cluster their vaults as opposed to placing them randomly all over properties. He noted that clustering serves a purpose of making it easier to landscape. He also noted that he has only worked with Google and they were very open to what the City desired in terms of aesthetics opting for green boxes to "match" the grass and using concrete topped boxes in sidewalks.


