

## Municipal Courts in Johnson County holding Amnesty Event in August

Municipal Courts throughout Johnson County will conduct a Warrant Amnesty Event from Saturday, August 11, to Friday, August 24.

Individuals with a warrant may appear in their designated court, at the specified time, to have their warrant canceled and warrant fee waived. See attached schedule for each court's Amnesty date and time.

Individuals appearing in court during the amnesty event will not be arrested on warrants from other participating Johnson County Municipal Courts prior to that court's Amnesty event. Prosecutors will be available to assist with the resolution of cases.

Please note all warrants remain active until resolved and can be served by an officer at any time you have contact with police, i.e. traffic stops, including during the amnesty event period.
