Cooper Creek Park Restoration to Continue in 2023

Walking through Cooper Creek Park today, you can see many of the improvements made during Phases 1 and 2 of the Restoration Project; the sculptures, flower beds, picnic table, benches and play structures draw you in and invite you to linger.

Less apparent are the steps taken to restore the park's riparian woodland ecosystem to a healthy state. These improvements—the heart of the Cooper Creek Restoration Project—included removing nonnative, invasive plants and replacing them with hundreds of native trees, shrubs and other plants.

Phase 3, which the city has budgeted \$12,331 for, will focus on completing and maintaining this important restoration work. Invasive plants will inevitably try to regain a foothold along the creek banks. These will be monitored and treated with herbicide as needed, so the native plants can thrive.

More trees and plants will be planted to increase diversity and to replace any casualties. The beds will be cared for and replenished with pollinator-friendly plants to maintain the park's status as a Monarch Waystation.

Another goal of Phase 3 is to raise awareness among residents of how they can help protect our local environment by planting native species and eradicating invasive plants in their own yards. In this way, the restoration of Cooper Creek's habitat may serve as an example that could benefit all of Roeland Park and its neighboring cities.

To that end, a sign providing information about the riparian woodland ecosystem and its restoration will be installed in the park, as will a Little Free Library filled with books about nature and our place in it. More information will be shared via QR codes that link to the city's website and through outreach to local schools and conservation groups.

WHAT'S GOING ON?

On December 19th the City Council voted to approve the TIF 4 project plan, the Rocks CID, the intent to issue IRBs, the development agreement with EPC, and the rezoning of the Rocks site

A public hearing was held on December 5th regarding the TIF 4 Project Plan. This was previously a part of TIF 3, but was carved out and only applies to the Rocks. It does not affect any other taxes or jurisdictions. The Planning Commission found that the TIF 4 Project Plan is consistent with the City's Comprehensive plan.

RESIDENTIAL ACCESS

- There will be a slight duration in which homeowners will not have access to their driveways – during the construction and cure-time of the curb and gutter adjacent to the driveway as well as the reconstruction and cure-time of the driveway approaches. **The closure of select driveways is expected to be limited to 3-5 days each (depending on weather).**
- Special accommodations will be made for those with special medical needs and those with disabilities.
- Street access will be limited to residents that live on Canterbury while street under demolition. Driveway access will be maintained except for the days listed above.

WHAT'S TO COME?

In March, the Planning Commission will vote to approve the final development plan presented by EPC. Once this plan is approved, pre-construction activities may begin. The development agreement approved by Council requires the construction commence by the end of Q2 2024 and be substantially complete by the end of Q2 2027.





New Charter Ordinance

On October 3rd, the Council approved Charter Ordinance 38 which outlines how vacancies on the Governing Body will be filled. This ordinance states:

- A vacant mayoral seat will be filled by appointment from the existing Council members until the next general election.
- A vacant council seat will be filled by application and appointment from eligible residents until the next general election.
- The interim appointees will have the opportunity to run for the remainder of the unexpired term.



R Park Wildflower Meadow

What's going on in the corner of R Park?

Volunteers have reimagined an unplanned 3000-square foot portion of the park into a wildflower meadow with incredible potential to benefit wildlife, visitors and native flora.

The wildflower meadow is a three-year phased project designed to beautify the park and to educate the public. The work began with thoughtful planning and a project approval from City Council. In early winter 2022, volunteers laid temporary landscape fabric to prepare the site. This temporary measure is to eradicate the existing weeds and to make the ground ready for seeding in the Spring/Summer. Once the site is adequately prepared, volunteers will remove the landscape fabric (and hopefully reuse it later), then rake the ground and plant a midwestern wildflower and grass mix. For immediate impact, we hope to include native plants arranged in a naturalistic pattern.

Wildflower meadows in Suburban and urban settings offer several advantages:

- Plant diversity attracts insects and other invertebrates (including butterflies, bees, spiders and beneficial wasps), birds, and small mammals
- Flowering species add a changing palette of color to the park throughout the seasons
- Provides insects and seeds for songbirds and wildlife.
- Provides habitat for pollinators including flowers for bees and host plants for butterfly caterpillars.
- Lowers maintenance costs and energy expenditures
- Once established, the native meadow does not need supplemental irrigation.
- Native plants have deeper root systems than traditional lawns and are better able to capture carbon and store water in the soil.



A wildflower meadow can be built on many acres or in a small pot on a porch or balcony! If you'd like to create your own wildflower meadow, there are many resources on the internet to help you get started.




