### **WHAT**

- green audio billboard; a story-telling/message-telling piece of technology

## WHERE

## HOW

- power comes from a manual crank (no electricity necessary)
- there is one at the 911 Memorial at the fire station at 135<sup>th</sup> and Metcalf
  - no parks in the KC area currently have or have had one
- loaned to the City; is cost-, maintenance-, and installation-free

### WHO

- Branding Stop is the company who owns the piece and would be responsible for creating the audio message (Roeland Park would write the message that would be recorded)
- Branding Stop would have a corporate leasing sponsor, so there would be mention of this business at the beginning of the audio message
